Requirements for Privilege License

All individuals and companies who engage in business of any kind within the corporate limits of the Town of Tunica are required by Mississippi state law to have a privilege license. Privilege licenses may be obtained by filling out an application and payment of applicable fee in Town Hall during normal business hours. Privilege license are valid for 1 year from the time they are issued. The cost of a privilege license is based on the type of business, the number of employees, and the value of the store inventory. The minimum fee for a privilege license is \$20.00.

Requirements to obtain a Privilege License:

1. Proof of State Sales Tax #
2. Proof of State Beer Permit if beer is sold at place of business.
3. Proof of Health Department Food Service Certificate if food is prepared and sold at place of business.
