1. The date, scale, north point, title, name of owner, and name of the person(s) preparing the site plan.
2. The location and dimensions of boundary lines easements, and required yards and setbacks of all existing and propose buildings and land improvements.
3. The location, height, and intended use of the existing and proposed buildings on the site, and the approximate location of the existing buildings on abutting sites within 50 feet.
4. The location of existing and proposed site improvements including parking and loading areas, pedestrian and vehicular access, utility or service areas, fencing and screening, and lighting.
5. The center line of the existing water courses, drainage features and location and size of existing and proposed streets and alleys, and the 100-year flood plain as determined from the Federal Emergency Management Agency's FIRM maps.
6. The number of existing and proposed off-street parking and loading spaces, and a calculation of applicable minimum requirements.
7. Topography proposed contours and trees on the site. Contour intervals should be 2 feet.
8. The approximate location and size of the proposed sings, if known.
9. The location and size of the existing and proposed landscaped areas.
